eBay Business Advisor Sweepstakes Official Rules

<u>Participation Requirements</u>: To participate, you will need to have a Facebook account. Creating an account is free but is subject to Facebook's terms and conditions: https://www.facebook.com/legal/terms. *If entering via a mobile device and using your wireless carrier's network, standard data charges from your wireless carrier may apply*.

Entry Requirements: During the Promotion Period, locate a Sponsor's Sweepstakes post on the eBay for Business Facebook_page_and take the following actions to receive one (1) entry:

Sponsor's Use of Entrant's Comment: Commenting on Sponsor's Sweepstakes Post constitutes entrant's consent to give Sponsor a royalty-free, irrevocable, perpetual, non-exclusive license to use, reproduce, modify, publish, create derivative works from, and display the comment in whole or in part, on a worldwide basis, and to incorporate it into other works, in any form, media or technology now known or later developed, including for promotional or marketing purposes. 6.
